As part of the Faculty's '<u>About Us</u>' features *Richard Samworth*, the new Director of the Statistical Laboratory, has recently been interviewed about the role of the Stats Lab, his own personal research, the role of the Statistics Clinic and the future direction of the Stats Lab.

The Winton Centre has been awarded a grant from the Nuffield Foundation for research into communicating uncertainty without undermining trust. The PIs are David Spiegelhalter and Sander van der Linden, along with post doc Anne Marthe van der Bles.
